

1. Taiwan in dynamic transition: nation-building and democratization / Edited by Ryan Dunch and Ashley Esarey. - Seattle: University of Washington Press, 2020.235p.



**Abstract:** Taiwan's emergent nationhood poses a fundamental challenge to the global political order. Following a remarkable transition from authoritarian rule to robust democracy, this island society has become a prosperous but widely unrecognized nation-state for which no uncontested sovereign space exists. Increasingly vigorous assertions of Taiwanese identity expose the fragility of relationships between the United States and other great powers that assume Taiwan will eventually unite with China. Perhaps because of their precarious international position, Taiwanese have embraced cosmopolitan culture and democratic institutions more fully than most Asians. The 2014 Sunflower Movement, in which demonstrators occupied parliament to protest a free trade agreement with China, thrust Taiwan politics into the global media spotlight, as did the resounding victory of the once-illegal Democratic Progressive Party in 2016. Taiwan in Dynamic Transition provides an up-to-date treatment of contemporary Taiwan, highlighting Taiwan's emergent nationhood and its implications for world politics. The book provides a new interpretive framework and series of case studies that together construct a vivid picture of how contemporary Taiwanese think about their nationhood, with specific examples of nation-building and democratization in social practice. The Taiwan case has important implications for broader themes and preoccupations in contemporary thought, such as consideration of why transitions in the aftermath of the Arab Spring have sputtered or failed, while Taiwan has evolved into a stable and prosperous democratic society. Taiwan serves as a test case for nation- and state-building, the formation of national identity, and the emergence of democratic norms in real time.



Abstract: This book analyzes the historical quest of the Islamic Republic of Iran to export its revolution to the Muslim countries in the Middle East and beyond. The authors argue that Iran exported its revolution by using proxies such as Hezbollah, the Iraqi Shite militias, and the Houthis. The study unravels the casual chain behind less-known cases of Iranian sponsorship of al Qaeda (Central) and al Qaida in Iraq. It combines rigorous theory with detailed empirical analysis which can add to the current debate about ways to roll back Iran's revolutionary export. Ofira Seliktar is Professor Emeritus of Political Science at Gratz College, USA. She is widely published and recently co-authored Iran, Israel, and the United States: The Politics of Counterproliferation Nuclear Intelligence with Farhad Rezaei. Farhad Rezaei is Iran's foreign policy analyst and author of numerous books and articles on Iran's foreign policy, Iran's nuclear program, nuclear intelligence, and nuclear and radiological terrorism. The African American experience was the most notable life force that produced the trans-Atlantic exchanges and continued to drive them until 1900. This process will likely continue to affect the future of United States-Africa relations.



Abstract: In 2013, Chinese leader Xi Jinping announced a campaign for national rejuvenation. The One Belt One Road initiative, or OBOR, has become the largest infrastructure program in history. Nearly every Chinese province, city, major business, bank, and university have been mobilized to serve it, spending hundreds of billions of dollars overseas building ports and railroads, laying fiber cables, and launching satellites. Drawing on primary documents in five languages, interviews with senior officials, and on-the-ground case studies from Malaysia to Greece, Russia to Iran, Freymann pulls back the veil of propaganda about OBOR, giving readers a page-turning world tour of the burgeoning Chinese empire, a guide for understanding China's motives and tactics, and clear recommendations for how the West can compete.
