

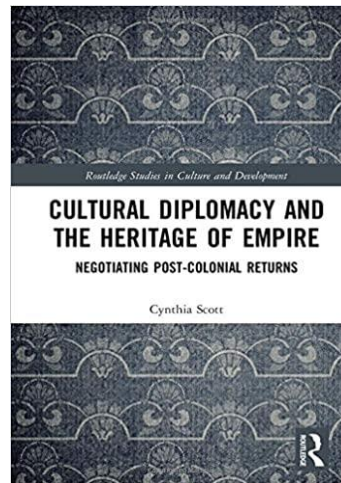

Cultural diplomacy and the heritage of empire : negotiating post-colonial returns / Cynthia Scott. - New York: Routledge, 2020. xiv, 202p.



Abstract: Cultural Diplomacy and the Heritage of Empire analyses the history of the negotiations that led to the atypical return of colonial-era cultural property from the Netherlands to Indonesia in the 1970s. By doing so, the book shows that competing visions of post-colonial redress were contested throughout the era of post-World War Two decolonization. Considering the danger this precedent posed to other countries, the book looks beyond the Dutch-Indonesian case to the 'Elgin (Parthenon) Marbles' and 'Benin Bronzes' controversies, as well as recent developments relating to returns in France and the Netherlands. Setting aside the 'universalism versus nationalism' debate, Scott asserts that the deeper meaning of post-colonial cultural property disputes in European history has more to do with how officials of former colonial powers negotiated decolonization, while also creating contemporary understandings of their nations' pasts. As a whole, the book expands the field of cultural restitution studies, and offers a more nuanced understanding of the connections drawn between post-colonial national identity making and the extension of cultural diplomacy. Cultural Diplomacy and the Heritage of Empire offers a new perspective on the international influence of the UNGA and UNESCO on the return debate. As such, the book will be of interest to scholars, students and practitioners engaged in the study of cultural property diplomacy and law, museum and heritage studies, modern European history, post-colonial studies and historical anthropology.

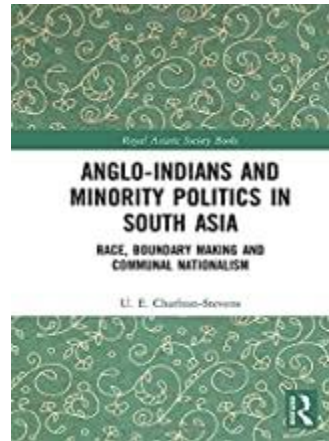

Anglo-Indians and minority politics in South Asia : race, boundary making and communal nationalism / Uther Charlton - Stevens. - New York: Routledge, 2018. xvi, 321p.



Abstract: Anglo-Indians are a mixed-race, Christian and Anglophone minority community which arose in South Asia during the long period of European colonialism. An often neglected part of the British Raj, their presence complicates the traditional binary through which British imperialism is viewed – of ruler and ruled, coloniser and colonised. The book analyses the processes of ethnic group formation and political organisation, beginning with petitions to the East India Company state, through the Raj’s constitutional communalism, to constitution-making for the new India. It details how Anglo-Indians sought to preserve protected areas of state and railway employment amidst the growing demands of Indian nationalism. Anglo-Indians both suffered and benefitted from colonial British prejudices, being expected to loyally serve the colonial state as a result of their ties of kinship and culture to the colonial power, whilst being the victims of racial and social discrimination. This mixed experience was embodied in their intermediate position in the Raj’s evolving socio-racial employment hierarchy. The question of why and how a numerically small group, who were privileged relative to the great majority of people in South Asia, were granted nominated representatives and reserved employment in the new Indian Constitution, amidst a general curtailment of minority group rights, is tackled directly. Based on a wide range of source materials from Indian and British archives, including the Anglo-Indian Review and the debates of the Constituent Assembly of India, the book illuminatingly foregrounds the issues facing the smaller minorities during the drawn out process of decolonisation in South Asia. It will be of interest to students and researchers of South Asia, Imperial and Global History, Politics, and Mixed Race Studies.

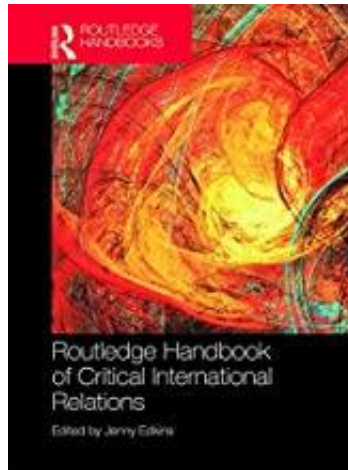

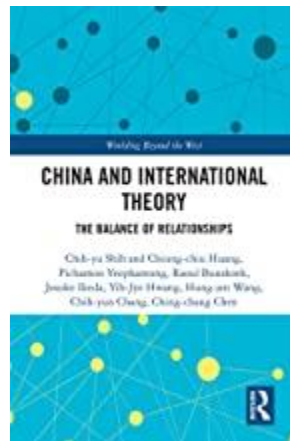

China and international theory : the balance of relationships / Chih-yu Shih et al.. - New York: Routledge, 2019. xvi, 285p.



Abstract: Major IR theories, which stress that actors will inevitably only seek to enhance their own interests, tend to contrive binaries of self and other and 'inside' and 'outside'. By contrast, this book recognizes the general need of all to relate, which they do through various imagined resemblances between them. The authors of this book therefore propose the 'balance of relationships' (BoR) as a new international relations theory to transcend binary ways of thinking. BoR theory differs from mainstream IR theories owing to two key differences in its epistemological position. Firstly, the theory explains why and how states as socially-interrelated actors inescapably pursue a strategy of self-restraint in order to join a network of stable and long-term relationships. Secondly, owing to its focus on explaining bilateral relations, BoR theory bypasses rule-based governance. By positing 'relationality' as a key concept of Chinese international relations, this book shows that BoR can also serve as an important concept in the theorization of international relations, more broadly. The rising interest in developing a Chinese school of IR means the BoR theory will draw attention from students of IR theory, comparative foreign policy, Chinese foreign policy, East Asia, cultural studies, post-Western IR, post-colonial studies and civilizational politics.

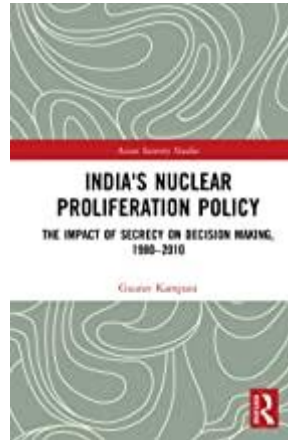

India's nuclear proliferation policy : the impact of secrecy on decision making, 1980-2010 / Gaurav Kampani. - New York: Routledge, 2020. ix, 184p.



Abstract: This book examines India's nuclear programme and shows how secrecy inhibits learning in states and corrodes the capacity of decision makers to generate optimal policy choices. Focusing on clandestine Indian nuclear proliferation during 1980-2010, the book argues that efficient decision-making is dependent on strongly established knowledge actors, high information turnover, and the capacity of leaders to effectively monitor their agents. When secrecy concerns prevent states from institutionalizing these processes, leaders tend to rely more on heuristics and less on rational thought processes in choices involving matters of great political uncertainty and technical complexity. Conversely, decision-making improves as secrecy declines and policy choices become subject to higher levels of scrutiny and contestation. The arguments in this work draw on compelling evidence gathered from interviews conducted by the author, with interviewees including individuals who were involved in nuclear planning in India from 1980 to 2010, such as former cabinet and defence secretaries, the principal secretary to the prime minister, national security advisors, secretaries to the department of atomic energy, military chiefs of staff and their principal staff officers, and commanders of India's strategic (nuclear) forces. This book will be of much interest to students of nuclear proliferation, Asian politics, strategic studies and International Relations.

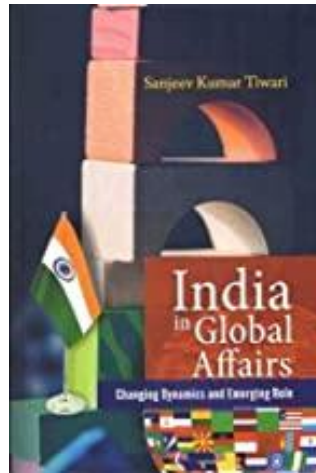

Abstract: This book is a critical analysis of how the discursive and material practices of the "War on Terror" influenced security politics in Southeast Asia after 9/11. It explores how the US-led War on Terror, operating both as a set of material practices and as a larger discursive framework for security, influenced the security of both state and non-state actors in Southeast Asia after 9/11. Building on the author's own critical security studies approach, which demands a historically and geographically contingent method of empirically grounded critique, *Writing Southeast Asian Security* examines some of the unexpected effects that the discourses and practices of the War on Terror have had on the production of insecurity in the region. The cases presented here demonstrate that forms of insecurity were constructed and/or abetted by the War on Terror itself, and often occurred in concert with the practices of traditional state-centric security. This work thus contributes to a larger critical project of revealing the violence intrinsic to the pursuit of security by states, but also demonstrates pragmatic opportunities for a functioning politics of theorizing security. 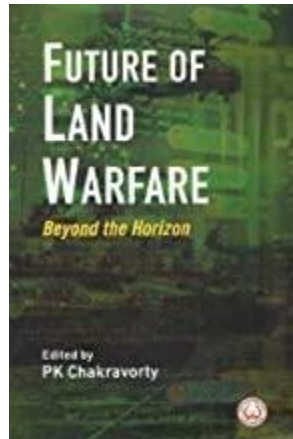

Abstract: The book deals with future of land warfare on the Indian subcontinent. To predict about the future is extremely difficult particularly in the field of Warfare. This is due to the fact; wars are impacted by doctrine, technology and people. Further the introduction of nuclear weapons has made war less frequent and reduced the duration. There are trends which keep changing with the passage of time. Conflicts in the 21st century are short and swift with a combination of effects. Further aspirations of leaders often point towards different military objectives. In such a scenario we could plan at best for a decade and maybe visualise for about 15 years. By and large wars of the future would be, conventional, hybrid and would be interstate or with non-state actors. The causes could be territorial or related to historical differences, ideological biases, economic disparity, security and water distribution. Further issues could exacerbate due to impact of climate change, higher rate of population growth of minorities and sectarian or ethnic extremism. The future wars are likely to follow three types. It could be overt, covert and finally outsourced. The future battle space as visualised in the next 15 years would have characteristics which would make it non linear in time and space. Unlike wars of the past they would be swift and would be based on speed. Targets would need to be precisely engaged to avoid collateral damage. Operations would demand jointness between the three services. Further they would be continuous with no pauses. They could be termed as 24x7 operations. In these operations connectivity would play an important part and communications would be available to soldiers, commanders and autonomous weapon systems and vehicles. There would be a need for synergy between air, sea, and outer space while undertaking land warfare. Perception management becomes extremely important as this alone would lead to an effective reorganisation of people. Finally technology would play an important role particularly, the application of artificial intelligence.

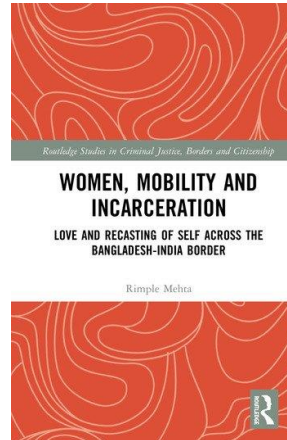

Women, mobility and incarceration : love and recasting of self across the Bangladesh-India border / Rimple Mehta. - Abingdon, Oxon: Routledge, 2018. xvii, 161p.



Abstract: This book explores how Bangladeshi women from poor and undereducated/semi-educated backgrounds who have crossed the Indo-Bangladesh border find themselves in prisons serving sentences under the Foreigners Act, 1946. Drawing on original fieldwork, this book explores these women's understanding of borders and state sovereignty and how the women - from conservative rural and semi-rural backgrounds which impose a strict moral code - adjust to the socio-cultural context of an Indian prison, where being an inmate is "dishonourable" in their community. Further, it focuses on the negotiations that the Bangladeshi women make with the social and political borders they encounter in the process of crossing the Indo-Bangladesh border without requisite documents needed by the state for entry into a "foreign" land; how they cope with the daily challenges of living during their imprisonment in a correctional home; and their feelings about their impending return to Bangladesh. Women who are apprehended and criminalised for crossing borders must negotiate with not only the normative understanding of borders which is inherently masculine in nature, but also the gender biased lens through which female mobility is viewed: therefore, they not only cross political borders but also social borders. This book maps the associations between women's experiences of mobility and incarceration, and their linkages with social and political borders and the fraught experiences of being in a 'foreign' territorial space. It will be important reading for criminologists, sociologists, and those engaged in penology, women's studies and migration studies.

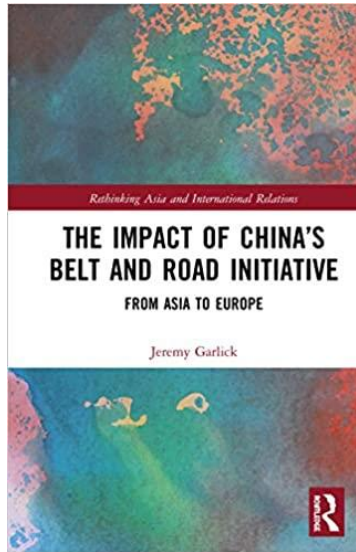

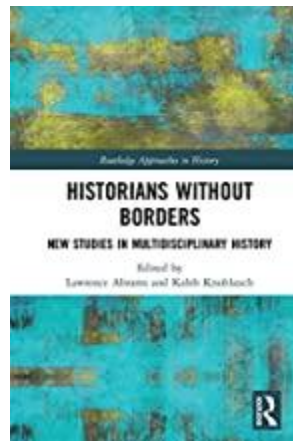

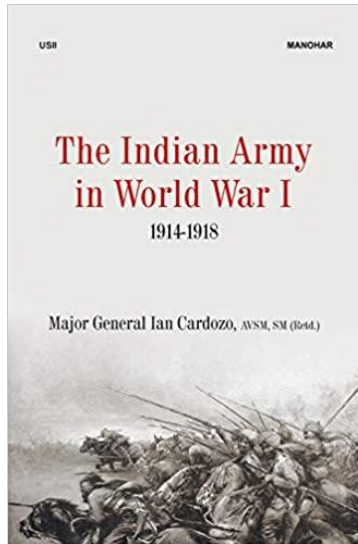

Abstract: This volume tells the story of India's contribution to the Great War – a war that resulted in the decimation of ten million soldiers and twenty million civilians, the destruction of the youth of Europe and the Ottoman, Russian and Austrian dynasties and hastened the demise of the British and French empires, gave rise to Nazism, Fascism, Communism and is the progenitor of all the wars since then in Europe and the Middle East. India's participation in this most destructive war had the support of Indian politicians of that time, because Britain gave a commitment that if India wanted 'Dominion Status' then it would need to take part in this war. Seven expeditionary forces were sent to fight on the battlefields of Europe, Asia and Africa. It is generally accepted that the first expeditionary force which was sent to Europe was largely responsible for stopping the German advance to Paris and the Channel ports. Over a million Indian soldiers were sent overseas of which 74,000 were killed, twice that number was wounded and 60,000 declared missing. India was the largest contributor not only in men but also in money, animals and equipment. Regrettably the story of the part played by the Indian soldier in this war has not been adequately told. Indian authors and the United Service Institution of India have attempted to fill this gap. This is one of the few books that has tried to redress this imbalance.

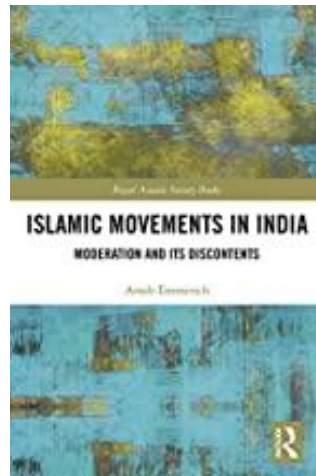

Islamic movements in India : moderation and its discontents / Arndt-Walter Emmerich. - New York: Routledge, 2020. xiii, 214p.



Abstract: This book analyses the emerging trend of Muslim-minority politics in India and illustrates that a fundamental shift has occurred over the last 20 years from an identity-dominated, self-serving and inward-looking approach by Muslim community leaders, Islamic authorities and social activists that seeks to protect Islamic law and culture, towards an inclusive debate centred on socio-economic marginalisation and minority empowerment. The book focuses on Muslim activists, and members and affiliates of the Popular Front of India (PFI), a growing Muslim-minority and youth movement. Drawing on qualitative fieldwork undertaken since 2011, the author analyses recent literature on Muslim citizenship politics and the growing involvement of Islamist organisations and movements in the democratic process and electoral politics to demonstrate that religious groups play a role in politics, development, and policy making, which is often ignored within political theory. The book suggests that further scrutiny is needed of the assumption that Muslim politics and Islamic movements are incompatible with the democratic political framework of the modern nation state in India and elsewhere. Contributing to a more nuanced understanding of how Islamic movements utilise various spiritual, organisational and material resources and strategies for collective action, community development and democratic engagement, the book will be of interest to academics in the field of political Islam, South Asian studies, sociology of religion and development studies.

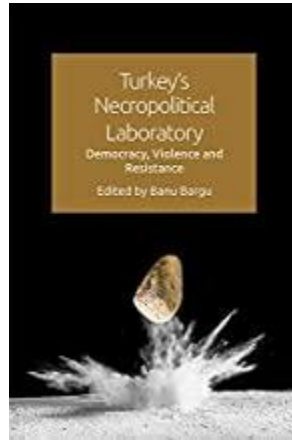
